## **2021-2022 Academic Year** **Safe Return and Continuity of Services Plan**

### **Universal and correct wearing of masks**

--Dibble Public School does not have a policy that requires students, staff, and patrons to wear masks. Masks are encouraged but not mandated.

### **Modifying facility to all for physical distancing**

--Dibble Public school will continue to monitor the spread of COVID-19. In the event that the district or local health officials determine an increase in the spread of the virus, we will limit building occupancy to minimize the spread of the virus. It is not practical nor possible for the district to alter facilities for total physical distancing.

### **Handwashing and respiratory etiquette**

--The district will continue to encourage proper handwashing in addition to providing hand sanitation facilities and opportunities throughout the facilities.

### **Cleaning and maintaining healthy facilities, including improving ventilation.**

--The district has invested in additional sanitation equipment, and is currently looking to equip large volume areas with air treatment systems.

### **Contact tracing in combination and isolation and quarantine, in collaboration with the State, Local Territorial, or Tribal health departments**

--Dibble Public School will work in conjunction with local health officials to monitor contact tracing, isolation, and quarantining. Specifically, the district will work with the McClain County Oklahoma Health Department.

### **Diagnostic and Screening testing**

--The district shall refer all suspected cases of Covid-19 to properly equipped and properly trained testing facilities.

### **Efforts to provide vaccinations to school communities**

--Dibble Public School will work in conjunction with the McClain County Oklahoma Health Department and the Chickasaw Nation Tribe of Oklahoma to give required or optional vaccines.

### **Appropriate accommodations for children with disabilities with respect to health and safety policies.**

--The district shall provide extended communication with parents and students to ensure proper service. IEP's, 504's and ELL student services will be followed as determined by the appropriate team(s).

### **Coordination with State and local health officials**

--Dibble Public School will consult with liaisons from the McClain County Oklahoma Health Department and the Chickasaw Nation Tribe. All positive contacts and quarantines are logged through the Oklahoma State Department of Education Covid-19 portal.

### **Continuity of Services**

--The district shall provide distance learning opportunities through the Tri-City Learning Academy. In addition the district will make counseling services available to address the mental health needs of students and staff.
